This is a Public Information Act Request. I would politely request the following items:

1. a copy of the powerpoint presentation Ed Archuleta delivered at the May 7, 2008, meeting of the Public Service Board. I would prefer a copy of the electronic file. If it is easier, I will accept copies of individual slides;
2. a list of or documents that identify all planned and proposed capital expenditures the PSB intends to fund or has considered funding with the stormwater drainage fee;
3. a list of or documents that reflect all capital improvement projects the PSB intends to fund or has considered funding with stormwater drainage fees;
4. documents presented to or at meetings of the Public Working Group the PSB organized regarding the design and implementation of the stormwater drainage fee;
5. documents that reflect the total expenditures on television advertisements regarding the PSB's stormwater drainage fee and the stormwater drainage utility in 2008; and

- documents that reflect all bid solicitations, bid responses, proposed layouts and storyboards for television and other advertisements regarding the PSB's stormwater drainage fee and the stormwater utility.
